ORDINANCE NO. 144

AN ORDINANCE of the City Council of the City of Lakewood, Washington creating a new Section 15.16.030 of the Lakewood Municipal Code regarding Fire Code and Fire Marshal Fees

WHEREAS, the City of Lakewood adopted by reference provisions of the Uniform Fire Code that identify certain tasks to be performed by the person designated as the Fire Marshal for the City, and other Ordinances such as the Fireworks Ordinance also designated the City's Fire Marshal as the person responsible for certain tasks involved therewith; and,

WHEREAS, in keeping with the intent that the costs and fees of the City be in amounts reflecting the actual costs, it is appropriate that these fees be set forth in the fee schedule for the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON DO ORDAIN as follows:

Section 1. That a new Section 15.16.030 of the Lakewood Municipal Code be, and the same is hereby created to read as follows:

15.16.030 Uniform Fire Code and Fire Marshal Fees.

The fees for the services performed by the Fire Marshal pursuant to the Uniform Fire Code and City Ordinance shall be identified and set forth in the adopted City Fee Schedule.

Section 2. That if any provision of this Ordinance or its application to any person or circumstance is held invalid, the remainder of this Ordinance or the application of the provision to other persons or circumstances shall not be affected.

Section 3. That this Ordinance shall be in full force and effect five (5) days after publication of the Ordinance Summary, as required by law.
