ORDINANCE NO. 18

AN ORDINANCE of the City of Lakewood, Washington relating to fees charged for services provided by the City

WHEREAS, the City is authorized to establish fees and charges for services provided; and,

WHEREAS, the City desires to recover the cost of services where fees may be appropriate.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON, DO ORDAIN as follows:

Section 1. Fees Established. The fees and charges for services provided by the City are established as set forth on the list attached hereto, marked as Exhibit AA@ and incorporated herein by this reference. In addition thereto, the City may hereafter establish or amend fees or charges for services provided by the City by Resolution.

Section 2. Severability. If any section, sentence, clause, or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

Section 3. Effective Date. This ordinance shall be effective five (5) days after publication of the Ordinance summary and on February 28, 1996
