ORDINANCE NO. 201

AN ORDINANCE of the City Council of the City of Lakewood, Washington, vacating portions of 34th Avenue South, in the City of Lakewood

WHEREAS, the City of Lakewood, Washington, has received a petition by not less than two-thirds (2/3) of the owners of property adjacent to portions of 34th Avenue South and vacated Chapel Street, in the City of Lakewood, requesting vacation of the same; and,

WHEREAS, a public hearing was held in connection with the possible vacation, with notice having been provided pursuant to statute; and,

WHEREAS, the City Council of the City of Lakewood, Washington, has considered all matters presented at the public hearing on the proposed vacation, held on the 5th day of April, 1999, at the Lakewood City Council Meeting held on that day, in Lakewood, Washington.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON DO ORDAIN as a non-codified ordinance as follows:

SECTION ONE. That those portions of 34th Avenue South and the Northerly margin of vacated Chapel Street, in the City of Lakewood, Washington, described more particularly hereinbelow, and as shown on the map attached hereto, marked Exhibit "A" and incorporated herein by this reference, be, and the same hereby is vacated, provided that the City of Lakewood reserves an easement for utilities over, under and on the vacated right-of-way, and further reserves the right to grant easements for utilities over, under and on that portion of the vacated right-of-way described hereinbelow:

THE WESTERLY 10.00 FEET OF 34TH AVENUE SOUTH LYING SOUTHERLY OF THE NORTHERLY MARGIN OF VACATED CHAPEL STREET AND NORTHERLY OF THE NORTHERLY MARGIN OF 112TH STREET SOUTH.

CONTAINING 10,333 SQUARE FEET, OR 0.24 ACRES, MORE OR LESS.


SECTION TWO. That this vacation shall be in full force and effect upon the following conditions: (a) payment to the City of
