ORDINANCE NO. 234

AN ORDINANCE of the City Council of the City of Lakewood, Washington amending the 2000 budget with revenues and appropriations

WHEREAS, pursuant to the provisions of Chapter 35A.33 of the Revised Code of Washington, the City is required to adopt an annual budget and provide for procedures for filing of estimates, preliminary budgets, deliberations, public hearings and final fixing of the budget; and,

WHEREAS, pursuant to the provisions of the Revised Code of Washington, a preliminary budget for the fiscal year 2000 was prepared and filed, requisite public hearings were held for the purpose of fixing a final budget and the City Council made deliberations and adjustments as deemed necessary and proper, and adopted the budget for the City of Lakewood for the fiscal year 2000, which budget was adopted through Ordinance No. 221, on the 15th day of November, 1999; and,

WHEREAS, after the budget was adopted, it was recommended by the state Auditor that certain grant funds be transferred to the City's Grant Fund rather than remaining in the City's General Fund; and,

WHEREAS, because of such action, it is appropriate that the 2000 budget be amended to provide for such transfer, with a public hearing on the proposed budget amendment having been held on the 19th day of June, 2000, at which hearing all persons wishing to speak to the amendment of the 1999 budget were heard.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON DO ORDAIN as follows:

Section 1. The 2000 budget for the City of Lakewood, covering the period from January 1, 2000 through December 31, 2000, as adopted by Ordinance No.221, be, and the same hereby is amended to reflect the Funds, Revenues, Sources and Balances, with amended 2000 Budget totals of \$58,756,020 each for Revenues and for Expenditures, as shown on the summaries attached hereto, marked as Exhibit "A" and Exhibit "B," both of which are incorporated herein by this reference.

Section 2. Salary Ranges for New/Changed Employee Positions.

The list of Employee Position Titles, Salaries and Salary Ranges of the City, in accordance with the amounts of employee salaries and costs in the 2000 budget, shall be added to and amended to reflect the following:
