## ORDINANCE NO. 33

AN ORDINANCE of the City Council of the City of Lakewood, Washington amending Ordinance No. 2, amending the established plan for salary, benefits and working conditions for City employees

WHEREAS, following the vote approving incorporation of the City of Lakewood, Washington as a non-charter optional code city under the City Council-Manager form pursuant to the provisions of chapter 35A.13 of the Revised Code of Washington, and the election of an initial City Council, the City Council has taken action to facilitate municipal operations of the City, as authorized by RCW 35.02.130; and,

WHEREAS, in order for the City to address the responsibilities involved in its municipal functions, and to assist the City Manager of the City in hiring trained and qualified individuals to serve as employees of the City in the City's various departments, the City Council adopted an Ordinance establishing a compensation plan for wages, benefits and working conditions of City employees, identified as City of Lakewood Ordinance No. 2; and,

WHEREAS, since the time of the adoption of said Ordinance No. 2, and in conformity with the approved budgets, it is appropriate for the City to hire additional staff and to add those new employee positions to the compensation plan for wages, benefits and working conditions.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON DO ORDAIN as follows:

Section 1. That City of Lakewood Ordinance No. 2 is hereby amended to add the employment positions and salaries, as set forth on the attached Exhibit "A" incorporated herein by this reference, to the established compensation and benefits plan for non-contract employees of the City, providing for wages, benefits and working conditions.

Section 2. That this Ordinance shall be in full force and effect five (5) days after publication of the Ordinance Summary and on February 28, 1996, provided that the terms of this Ordinance shall also be in effect in the interim period prior to February 28, 1996.
