ORDINANCE NO. 378

AN ORDINANCE of the City Council of the City of Lakewood, Washington, amending chapter 13.06 of the Lakewood Municipal Code, specifically section 13.06.150, relating to rates and charges for garbage collection services

WHEREAS, the City has established a system for handling solid waste and recycling pursuant to its obligations to protect the public health, safety and welfare; and,

WHEREAS, the City has entered into an agreement for solid waste and recycling services with a private contractor in order to responsibly implement its system; and,

WHEREAS, through Ordinance No. 337, the City established operation standards and procedures for recycling collection services in February of 2004, which standards were amended in January of 2005 through Ordinance No. 371; and,

WHEREAS, as cited in Ordinance No. 371, it is contemplated that increased recycling services will tend to decrease the cost of services to citizens, an additional service level choice is necessary whereby for a decreased rate citizens may in some instances choose once-per-month automated garbage collection services at a reduced fee where previously only weekly or bi-weekly automated service options were available.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON, DO ORDAIN, as follows:

Section 1. That section 13.06.150 of the Lakewood Municipal Code be, and the same is hereby amended to read as follows:
