RESOLUTION NO. 1997-11

A RESOLUTION of the City Council of the City of Lakewood, Washington, authorizing the submission of an application for a modification of the Comprehensive Urban Growth Area for the City of Lakewood and for development of and modification of Text amendments to the Pierce County Comprehensive Plan as a part of Pierce County=s 1997 amendment process

WHEREAS, pursuant to the provisions of RCW 36.70A.110, Pierce County and the City of Lakewood are required to provide and establish urban growth areas; and,

WHEREAS, the City Council of the City of Lakewood, Washington promulgated the amendment of the Comprehensive Urban Growth Areas (CUGA) through the Pierce County Comprehensive Plan amendment process; and,

WHEREAS, the City has identified omissions and inconsistencies in the Pierce County Comprehensive Plan regarding urban areas adjacent to the City, and which significantly impact the City; and,

WHEREAS, the City desires to submit to the County for its consideration and processing an amendment to the Comprehensive Urban Growth Area (CUGA); and,

WHEREAS, in support of the proposed amendment to the CUGA, it would be appropriate to submit language text to address the City

WHEREAS, pursuant to the provisions of RCW 36.70A.110, Pierce County and the City of Lakewood are required to provide and establish urban growth areas; and,

WHEREAS, in support of the proposed amendment to the CUGA, it would be appropriate to submit language text to address the City=s proposal; and, WHEREAS, it is appropriate that the City staff develop language to provide such support for the City=s proposed amendment to the CUGA for submission to the County for its consideration; and,

WHEREAS, if the proposed changes to the Comprehensive Urban Growth Area (CUGA) are approved by Pierce County, the City Council intends to apply for amendments to its service area boundaries so as to include portions of Ft. Lewis and McChord Airforce Base in the next application cycle.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON, HEREBY RESOLVES as follows:

Section 1. That the City Council of the City of Lakewood adopts and endorses the amendment to CUGA as described in and as shown on the map attached hereto marked as Exhibit AA@ and incorporated herein by this reference, and request that Pierce County include this proposal in its urban growth area amendments during its 1997 amendment process.

Section 2. That City staff is authorized to develop language for text amendments to Pierce County to modification of its comprehensive plan to support the City=s proposed amendment of the CUGA as a part of Pierce County=s 1997 amendment process.

Section 3. That a copy of this Resolution shall be forwarded to the Pierce County Council and Pierce County Department of Planning and Land Services.

Section 4. That this Resolution shall be in full force and effect upon passage and signatures hereon.

Section 3. That a copy of this Resolution shall be forwarded to the Pierce County Council and Pierce County Department of Planning and Land Services.

Section 4. That this Resolution shall be in full force and effect upon passage and signatures hereon.
