RESOLUTION NO. 1998-14

A RESOLUTION of the City Council of the City of Lakewood, Washington, providing for amendment to the City of Lakewood Fee Schedule, to provide for inclusion of fees for GIS related fees and costs, updating schedule of fees adopted through prior Ordinances and Resolutions accordingly

WHEREAS, in connection with the municipal functions and operations of the City of Lakewood, the City provides various public services, a number of which entail fees; and,

WHEREAS, the City Council provided for adoption of fee schedules in the adoption of Ordinance No. 18, and Resolution Numbers 1996-4, 1996-5, 1996-14, 1996-32, 1997-7; 1997-14, 1997-18, 1997-31, 1997-32 and 1998-10; and,

WHEREAS, among the municipal activities with which the City has become involved is development of a Geographic Information Services (GIS); and,

WHEREAS, in connection with such functions and in light of the City policy of identifying fees based on the actual costs to the City, it is appropriate to include the costs for GIS labor and copy costs in the fee schedule of the City.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON HEREBY RESOLVES, as follows:

Section 1. That the Fee Schedule of the City of Lakewood is amended to include the fees for GIS labor and copy costs, and the Fee Schedule is accordingly updated as set forth on the document attached hereto, marked as Exhibit AA@ and incorporated herein by this reference.

Section 2. That this Resolution shall be in full force and effect upon passage and signatures hereon.

Hearing Examiner Fees. The term "Hearing Examiner" shall be synonymous with the term "consultant" as it appears in this Fee Schedule. Fees set in the Fee Schedule pertaining to applications before the Hearing Examiner shall include four (4) hours of the Hearing Examiner time. Hearing Examiner time in excess of four (4) hours shall be paid by the applicant at the rate of one hundred dollars (\$100) per hour. The Community Development Director or designee shall estimate the case hours of an application and require a deposit from the applicant to cover the estimated fees over four (4) hours. Where a combined application or appeal is to be heard by the Hearing Examiner, all fees shall be applied to the initial four (4) hours of time simultaneously. Subsequent hourly fees shall be divided among the applicants as determined by and in the sole discretion of the Community Development Director or designee so as to provide for an apportionment thereof in a fair and reasonable manner in light of the circumstances of and factors pertinent to the applications.

Non-Conforming Sign Permit fees. The permit fee shall be zero dollars (\$0) if the permit is obtained within ninety (90) days of receipt of notification by the City advising the applicant of the need to obtain a permit. F. FIRE MARSHAL OFFICE & UNIFORM FIRE CODE (UFC) FEES

CONSTRUCTION PLAN REVIEW

A plan review fee will be charged for fire department review of requirements for construction and inspection of the Uniform Fire Code requirements for buildings classified as Group A, B, E, F, H, I, M, R, S and U. The plan review fee shall be 15% of the plan review fee established by the Uniform Building Code fee schedule as adopted by the City, with a minimum fee of \$42.00.

FALSE FIRE ALARMS

In the event of more than two false alarms in any 90-day period, the Chief may charge a fee for fire department response as specified below:

False Alarms Fee

First and second No Fee

Third \$50.00

Fourth and additional \$250.00 each

EXCEPTION: False alarms resulting from the failure of a fire alarm service technician notifying the central, proprietary or remote monitoring station shall be billed at the rate of \$250.00 for each occurrence.

A liability insurance policy(s) is/are required in accordance with the Fireworks Ordinance and as follows for both fireworks stands and public displays.

- C. \$500,000 for damage to property in any once accident or occurrence.**
- D. \$1,000,000 combines single limit for any one accident or occurrence.**

A Bond for Clean up is required in accordance with the Fireworks Ordinance in the amount of \$500.00 in a bond or cashiers check for all fireworks stands.

The plan review fee for fire sprinkler systems shall be 25% of the permit fee, with a minimum fee of \$42.00. Plan review fees are in addition to the permit fee.

F. FIRE MARSHAL OFFICE & UNIFORM FIRE CODE (UFC) FEES

CONSTRUCTION PLAN REVIEW

A plan review fee will be charged for fire department review of requirements for construction and inspection of the Uniform Fire Code requirements for buildings classified as Group A, B, E, F, H, I, M, R, S and U. The plan review fee shall be 15% of of the plan review fee established by the Uniform Building Code fee schedule as adopted by the City, with a minimum fee of \$42.00.

FALSE FIRE ALARMS

In the event of more than two false alarms in any 90-day period, the Chief may charge a fee for fire department response as specified below:

False Alarms Fee

First and second No Fee

Third \$50.00

Fourth and additional \$250.00 each

EXCEPTION: False alarms resulting from the failure of a fire alarm service technician notifying the central, proprietary or remote monitoring station shall be billed at the rate of \$250.00 for each occurrence.

FIREWORKS FEES

a. Fees for temporary fireworks stand permit \$100.00

b. Fees for a public display permit \$245.00

A liability insurance policy(s) is/are required in accordance with the Fireworks Ordinance and as follows for both fireworks stands and public displays.

A. \$500,000 for injuries to any one person in one accident or occurrence.

B. \$1,000,000 for injuries to two or more persons in any one accident or occurrence.

C. \$500,000 for damage to property in any once accident or occurrence.

D. \$1,000,000 combines single limit for any one accident or occurrence.

A Bond for Clean up is required in accordance with the Fireworks Ordinance in the amount of \$500.00 in a bond or cashiers check for all fireworks stands.

The fee for fire sprinkler systems shall be based on the building permit fees shown in table 1-A of the Uniform Building Code as adopted by the City. The valuation shall be based on the per square foot figure for sprinkler systems as shown on the most recent Building Valuation Data printed in the Building Standards published by ICBO.

The plan review fee for fire sprinkler systems shall be 25% of the permit fee, with a minimum fee of \$42.00. Plan review fees are in addition to the permit fee.
