RESOLUTION NO. 1998-25

A RESOLUTION of the City Council of the City of Lakewood, Washington, setting a public hearing to consider the extension of the moratorium on the filing of applications for licenses, permits and approvals for adult entertainment businesses

A RESOLUTION of the City Council of the City of Lakewood, Washington, setting a public hearing to consider the extension of the moratorium on the filing of applications for licenses, permits and approvals for adult entertainment businesses

WHEREAS, in connection with the intention of the City Council of the City of Lakewood to develop licensing and business regulations for adult entertainment businesses, as well as a City Comprehensive Plan and zoning codes to address land use issues related to adult entertainment businesses, the City Council commissioned its Planning Advisory Board or an ad-hoc committee thereof to study the issues involved in adult entertainment in order to bring back to the City Council recommendations for adult entertainment businesses; and,

WHEREAS, the Planning Advisory Board and its ad-hoc Adult Entertainment Citizen's Task Force did complete the study of issues involved in adult entertainment and did bring back to the City Council recommendations for licensing regulations for adult entertainment businesses, ultimately being incorporated in City of Lakewood Ordinance No. 171, adopted by the City Council on May 18, 1998; and,

WHEREAS, although the City Council has now addressed licensing regulations for adult entertainment businesses, the work of the Planning Advisory Board and its ad-hoc committee related to zoning, land use and comprehensive planning for adult entertainment businesses is not completed, and additional time is needed to prepare its recommendation to the City Council for such zoning and land use regulations and comprehensive plan provisions; and,

WHEREAS, in order to insure adequate time to fully study the legal and practical factors involved in developing adult entertainment business zoning codes, land use regulations and comprehensive planning provisions for the City of Lakewood, the City Council established a moratorium on the filing of applications for licenses, permits and approvals for adult entertainment businesses through adoption of its Ordinance No. 50 and Ordinance No. 78, and further extended the moratorium through adoption of its Ordinance No. 111, Resolution No. 1997-26 and Resolution No. 1998-8, as allowed by section 35A.63.220 of the Revised Code of Washington (RCW); and,

WHEREAS, pursuant to RCW 35A.63.220, the City Council needs to hold a public hearing to consider the extension of the moratorium.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD,

WASHINGTON, HEREBY RESOLVES as follows:

1. That a public hearing on proposal to extend the moratorium on the filing of applications for licenses, permits and approvals for adult entertainment businesses be, and the same hereby is set for 7:00 p.m., or as soon thereafter as the matter can be heard, on the 17th day of August, 1998, at the City of Lakewood City Council Chambers, 10510 Gravelly Lake Drive S.W., Lakewood, Washington.

2. That this Resolution shall be in full force in effect upon passage and signatures hereon.
