## RESOLUTION NO. 1999-7

A RESOLUTION of the City Council of the City of Lakewood, Washington, naming Springbrook Park, naming Springbrook Community Services Center, and identifying their neighborhood

WHEREAS, since the time of the incorporation of the City of Lakewood on February 28, 1996, the City Council has endeavored to focus on the needs of the City in general and of the various areas and neighborhoods of which the City is comprised; and,

WHEREAS, the efforts of the City Council have been to take and promote actions which enhance commercial development in the business and commercial districts of the City, increase infrastructure amenities and to address the needs of residential neighborhoods of the City, which actions have included, among others, zoning and land use regulations consistent with the particular needs of neighborhoods and districts in the City, building and code enforcement actions to ensure safety and promote strength in land values, and support for community, park and recreation facilities; and,

WHEREAS, one of the initial parks and recreation projects with which the City has become involved is the development of a park in the neighborhood adjacent to the main gate to McChord Air Force Base; and,

WHEREAS, a neighborhood park in that residential neighborhood would enhance the quality of living in the neighborhood and provide amenities to the residents of the neighborhood consistent with the focus of the City Council to address areas of need within the City; and,

WHEREAS, in connection with the development of this neighborhood park, it is appropriate for the City to identify a fitting and appropriate name for this park, which name and which park could be a catalyst for positive beneficial attitudes and approaches to this neighborhood; and,

WHEREAS, it is also beneficial to identify and name the neighborhood community services center in the same neighborhood; and,

WHEREAS, in order to find such a name or names, the City has solicited suggestions and information regarding the historical, cultural and traditional uses, residents and geography from residents of the neighborhood and from citizens of the City familiar with the City's history and background.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON HEREBY RESOLVES, as Follows:

Section 1. That the park located at the corner of 127th Street Southwest and Addison Street S.W., in the City of Lakewood, Washington, shall be named Springbrook Park.

Section 2. That the neighborhood community services center located at the 12602 Bridgeport Way S.W., in the City of Lakewood, Washington, shall be referred to as Springbrook Neighborhood Community Services Center, which name shall apply to the City's use and tenancy of the property and building located thereon.

Section 3. That the neighborhood adjacent to the main gate to McChord Air Force Base, generally southeasterly of Interstate 5, shall be referred to, in City mapping and planning documents of the City as the Springbrook neighborhood.

Section 4. That this Resolution shall be in full force and effect upon passage and signatures hereon.
