RESOLUTION NO. 2000-33

A RESOLUTION of the City Council of the City of Lakewood, Washington, setting and establishing a schedule for amendments of the City of Lakewood Comprehensive Plan for 2001

WHEREAS, the City Council of the City of Lakewood adopted its initial Comprehensive Plan by Ordinance 237 on July 10, 2000; and,

WHEREAS, in connection therewith, it is appropriate for the City Council to periodically review its comprehensive planning elements and to amend the plan as warranted; and,

WHEREAS, the state law governing comprehensive plans limits how often they can be amended and further provides guidance and factors to be addressed in such amendments, including environmental considerations and public input considerations; and,

WHEREAS, in order to provide for a calendar of steps involved in the amendment process for the Comprehensive Plan amendments for the year 2001, it is appropriate for the City Council to set and establish a calendar.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF LAKEWOOD, WASHINGTON HEREBY RESOLVES, as Follows:

Section 1. That the calendar for the amendment process for the City of Lakewood Comprehensive Plan amendments for 2001 be, and the same hereby is, set and established as follows:

January 31 February 28

Deadline date for submittal of comprehensive plan amendments and filing fees.

February 28

February 16 March 16  
March 16

Community development checks for completed applications. Project proponents whose applications are deemed incomplete are provided an opportunity to submit revised applications.

February 19 - March 21

Initiation of review process. Applications are circulated to city departments and other public agencies. All comments shall be submitted to the community development department no later than 30-days of the department's mailing date.

March 19 - April 21

March 19 - April 21

Initiate SEPA process. Review SEPA checklists and identify likely significant adverse environmental impacts. If there are no impacts, or if the impacts can be sufficiently mitigated, issue a determination of nonsignificance or DNS (which may include mitigation measures). If there are impacts, issue determination of significance and

begin environmental impact statement (EIS) process.

### DNS EIS

For DNS (and no appeals), SEPA process is completed by about ~~May 21~~ **June 21**

14-day comment period 30-day scoping period

After comment period, lead agency retains DNS, revises DNS, or withdraws DNS. Prepare Draft EIS (DEIS).

For EIS (and no appeals), SEPA process completed by about ~~July 20~~ **August 20**

10-day environmental appeal period to Hearing Examiner. DEIS is circulated for 30-days; lead agency also holds a public hearing.

Lead agency responds to DEIS comments; prepares Final EIS (FEIS).

10-day environmental appeal period to Hearing Examiner

DNS process, minus appeals, takes about **60-days**. EIS process, minus appeals, takes about **120 days**.

Community development prepares report to the Planning Advisory Board (PAB).

With DNS - ~~June 6~~  
July 6

PAB conducts public hearing and makes recommendations to the City Council.

With EIS - ~~August 1~~  
September 1

With DNS - ~~June 25~~  
July 25

City Council conducts study session on comprehensive plan amendments.

With EIS - ~~August 13~~  
September 13

With DNS - ~~July 2~~  
August 2

City Council conducts public hearing and adopts ordinance.

With EIS - ~~August 20~~  
September 20

Section 2. This Resolution shall be in full force and effect upon passage and signatures hereon.
