## **CALL TO ORDER**

Mayor Harrison called the meeting to order at 7:02 p.m.

## REPORTS BY THE CITY MANAGER

City Manager Rohlfs distributed copies of an updated timeline for the Northwest Landing sewer line project. He explained that the Final Environmental Impact Statement (EIS) is being prepared and all of the alternatives for the project will be addressed in the Final EIS which is scheduled to be published in November 1996. In December 1996 Pierce County will be holding a public forum to receive public comment on the Final EIS.

City Manager Rohlfs announced that the September 9, 1996 Council Study Session will be held at the Lake City Community Center.

Lewis because of the closure of Woodbrook Drive; that two exits be placed at both ends of 150th Street; that the exit to I-5 travel into the middle of Tillicum at the old Log Center entrance; and to keep the overpasses at Exits 123 and 122 (American Lake Gardens to Tillicum and

Madigan to Tillicum).

Bill Kittrell, 7814 Emerald Drive, spoke about the need for access from Tillicum and American Lake Gardens to Lakewood.

Bob Neilan, 44 Chapman Loop, expressed support for the Cross Base Highway Project and suggested that consideration be given to the economic advantages and reduction of congestion along I-5 and SR-512 interchange.

Forrest Thompson, 14716 Portland Avenue, expressed the need for a highway and spoke about an alignment through Dupont.

Janet Prichard, Pacific Lutheran University, spoke about some of the methods identified in the book <u>Megatrends</u> and encouraged using reasonable methods to bring people together.

#### BRIEFING BY THE CITY MANAGER

City Manager Rohlfs reported on last week's meeting discussions with Pierce County on the parks and surface water management agreements. He indicated that in the original parks agreement proposal, the City would have taken over the neighborhood parks and pay for the maintenance and upkeep of these parks in 1996. In addition, a cost sharing agreement was being considered for American Lake and Harry Todd parks where the cost would have been \$151,000 and the City would pay one-third of the cost for American Lake and Harry Todd at \$50,000. That same agreement would translate in 1997 to \$52,000 and \$125,000 for American Lake and Harry Todd for a total of \$177,000. The proposal presented to Pierce County at the meeting was for the City to take over the neighborhood parks in January 1997 and also assume title to American Lake and Harry Todd parks in January for a total cost of \$190,000 (\$50,000 for neighborhood parks and \$140,000 for American Lake and Harry Todd parks). City Manager Rohlfs indicated that another meeting with Pierce County will be held in early September to discuss the parks proposal. He asked that Councilmembers let him know how they would like to proceed on this project.

With reference to surface water management, City Manager Rohlfs indicated that \$3.7 million have been collected in surface water management (SWM) funds. He indicated that the City will be pursuing the \$3.7 million to determine what percentage of projects should be designated for Lakewood's benefit. Staff will be developing recommendations. City Manager Rohlfs indicated that Pierce County has been billing for surface water management collection fees, however, the City has not agreed to these fees. City Manager Rohlfs noted that a meeting will be held in September to discuss these issues in greater detail.

### CITY COUNCIL COMMENTS

Councilmember Henry announced that the Events Ad Hoc Committee of eight interested individuals met. She announced that the next meeting is scheduled for

August 26, 1996 at 7:30 a.m. at Happy Days Restaurant. She encouraged all interested individuals to come.

Councilmember Davis provided an update on the Regional Transit Authority. She reported at a \$3.9 million regional transit proposal will be on the November ballot. She explained that the Regional Transit Authority is currently in the marketing phase and working on formulating factual documentation for the voters. She indicated that a grassroots effort campaign to support the RTA is currently being put together.

Councilmember Palmas asked the City Manager to addres the concerns that were expressed by citizens who testified about the sign ordinance. City Manager Rohlfs indicated that staff has communicated with the Chamber of Commerce about some staff concerns with the existing sign ordinance. He explained that the Chamber's Sign Committee is working on a proposal and City staff is awaiting their response. Mayor Harrison suggested that a letter be sent to the Chamber Board notifying them that Chamber Sign Committee members have approached the Council to express their concerns about the sign ordinance. Councilmember Henry indicated that the Chamber Board will be reviewing the Sign Committee's proposal on August 26, 1996. Councilmember Richardson suggested that after the Chamber Board presents their recommendations on the sign ordinance, that a Study Session with the Chamber Board and Council be held to discuss the proposal.

Deputy Mayor Thomas announced that on August 28, 1996 from 10:00 a.m. - noon, the Youth Task Force meeting will be held at the Clover Park School District Board Room. She asked Councilmembers if there were any issues they would like her to discuss with the group. It was suggested that the topics of curfew and jet skis be discussed with the group.

Mayor Harrison noted that in reference to City Attorney Heid's memorandum regarding the taking of any political action concerning Arrowhead/Partridge Glen, he asked Councilmembers to talk with City Attorney Heid.

Mayor Harrison asked for clarification on the information provided in the information bullet regarding legal debt margin. Finance Director Kidd explained how the figures were obtained with regard to the debt margins.

Mayor Harrison asked for a report on prior Council requests for information on the ethnic breakdown of the Lakewood police force, the algae problem at Lake Waughop and the police department's position on curfews. Councilmember

Richardson requested a report on the investigation of the incident on Lake Tapps which resulted in a fatality.

Mayor Harrison announced that a public meeting will be held on August 29, 1996 at 6:30 p.m. at the Health Department to discuss the closure of several health department free clinics including AIDS counseling, family planning and immunizations.

Mayor Harrison asked for a listing of the various organizations and their respective membership fees, such as the Puget Sound Air Pollution, who are seeking the City to join. City Manager Rohlfs indicated that staff will put together a list and provide recommendations.

Mayor Harrison reported that the Art and Antique Extravaganza was well done and well attended. He requested that a thank you letter be sent to the organizer of that event.

Deputy Mayor Thomas requested that a thank you letter be sent to Mary Gates for facilitating the Council Retreat on August 16, 1996.
