Reports by the City Manager

City Manager Rohlfs distributed copies of a memo on the status of the Tacoma Empowerment Consortium's (TEC) application for empowerment zone designation. He noted that the TEC was awarded \$3 million in planning funds in the year 2000.

City Manager Rohlfs distributed copies of a letter from the Society of Environmental Toxicology and Chemistry (SETC) noting that a team of SETC volunteers are proceeding with the peer review of Lake Steilacoom.

City Manager Rohlfs asked Councilmembers to let him know if they had any questions on AWC legislative issues. He indicated that Senator Winsley has requested City input on proposed public safety legislation.

City Manager Rohlfs announced that in the next Council Study Session, Council will be considering a bid for constructing sidewalks on the northwest corner of Pacific Highway and Bridgeport Way. He noted that the bid award will be much higher than was estimated because of the pavement patch work needed in that area.
