COUNCILMEMBER THOMAS MOVED TO AUTHORIZE THE EXECUTION OF A SOLE SOURCE AGREEMENT WITH PIERCE COUNTY CONSERVATION DISTRICT, IN AN AMOUNT NOT TO EXCEED \$60,000, FOR THE DESIGN AND CONSTRUCTION OF FISH PASSAGE IMPROVEMENTS AT FLETT AND CLOVER CREEKS. SECONDED BY COUNCILMEMBER DAVIS. VOICE VOTE WAS TAKEN AND CARRIED UNANIMOUSLY.

Motion No. 1999-16 authorizing the execution of an extension to the option agreement with Tom Meadowcroft, in the amount of \$30,000, to guarantee the purchase price of the proposed City Hall site on Mt. Tacoma Drive through April 17, 1999.

DEPUTY MAYOR THOMAS MOVED TO AUTHORIZE THE EXECUTION OF AN EXTENSION TO THE OPTION AGREEMENT WITH TOM MEADOWCROFT, IN THE AMOUNT OF \$30,000, TO GUARANTEE THE PURCHASE PRICE OF THE PROPOSED CITY HALL SITE ON MT. TACOMA DRIVE THROUGH APRIL 17, 1999. SECONDED BY COUNCILMEMBER PALMAS. VOICE VOTE WAS TAKEN AND CARRIED UNANIMOUSLY.

BRIEFING BY THE CITY MANAGER

There were no comments.

CITY COUNCIL COMMENTS

Councilmember Davis commented on the Sound Transit public hearing she attended in the Rainier Valley last week. She indicated that there were approximately 200 people at the hearing. Two-thirds of the people favored the construction of a tunnel, and one-third favored the grade crossing.

Councilmember Thomas reported that she, Deputy Mayor Thomas and Councilmember Richardson will be guests of the Air Force on an in-flight show-and-tell for two days; flying first to California, next to Illinois and then back to Washington state.

Councilmember Palmas reported on the citizens' Parks Bond Committee meeting he attended last week. He indicated that Clover Park School District has requested that the City's park bond election be scheduled before the voters at a different time than the Clover Park School District levy. He indicated that the Parks Bond Committee will be making a presentation before the Council sometime in March.

Mayor Harrison asked staff to check whether the County has taken action on the City's urban growth amendment application on the annexation of the military bases.

Mayor Harrison reminded staff of responding to the Pierce County Consortium's request to schedule a presentation before the Council regarding Community Development Block Grant programs.

Mayor Harrison requested that an article about code enforcement warnings and the notification process be included in the next City newsletter.

Mayor Harrison noted that he will try to make an effort to make an appearance at the March 3, 1999 Fort Lewis tour being sponsored by the Military Assistant Secretary.

Mayor Harrison asked for an update on the sewer hookups in Lakewood. Engineering Manager Larkin explained that staff has presented the County with a written request asking the County to define the differences in the proposed interlocal agreement and how the previous agreement had not met Federal mandates. Councilmember Thomas asked that Pierce County Councilmember Pat O'Malley be provided with copies of that correspondence.

Mayor Harrison asked staff to call the Fort Lewis Golf Course to be put on a waiting list in case of a cancellation for the Annual Holiday Awards Banquet. He noted that the November 20, 1999, date was too early for the banquet; and if Fort Lewis Golf Course was not available, another location should be found.

Engineering Manager Larkin reported that the architects for designing City Hall will be working with the City Hall Ad Hoc Committee. In addition the architects would like to establish a 15-20 member citizens' advisory committee to work on the designing of City Hall.

Mayor Harrison asked staff to obtain a copy of the letter and mailing list to interested citizens from Jan Wolcott, Pierce County

Mayor Harrison announced that Council would recess into Executive Session for approximately 5 minutes to discuss potential litigation.
