ITEMS FOR DISCUSSION:

Parks Master Plan and Proposed Parks Bond

Deputy City Manager Neiditz reviewed the proposed parks bond package and the improvements and developments planned for Lakewood parks under this bond package.

Citizens questioned what the annual cost will be to maintain the parks under this bond proposal. Deputy City Manager Neiditz indicated that the maintenance cost will be approximately \$215,000.

A question was asked if there will be other issues on the primary ballot with the parks bond. Deputy City Manager Neiditz indicated that the Pt. Defiance Park tax measure and a Lakewood fire levy are scheduled for the primary election.

A comment was made on the need to light Ft. Steilacoom Park soccer fields.

Jim Taylor, Clover Park School District Board President, commented that the School District is supportive of the parks bond proposal.

It was questioned if there was a provision for the Lakewood Community Center's recreation program in the parks proposal and who was going to be the "watchdog" of the Center.

A citizen questioned if there was provision to implement a boat launch fee on Lake Steilacoom. Deputy City Manager Neiditz indicated that there is no plan for this in the parks bond.

It was questioned whether the parks bond provides for maintenance of the Camp Murray boat launch on American Lake. Deputy City Manager Neiditz indicated that the parks package does not include maintenance for the Camp Murray boat launch.
