VOICE VOTE WAS TAKEN AND THE MOTION FAILED WITH COUNCILMEMBER HUMPHREY VOTING IN FAVOR AND COUNCILMEMBERS DAVIS, PALMAS, RICHARDSON, THOMAS, DEPUTY MAYOR THOMAS, AND MAYOR HARRISON VOTING IN OPPOSITION.
