REPORTS BY THE CITY MANAGER

PROCLAMATIONS AND PRESENTATIONS

Clover Park School District Board Report.

Clover Park School District Board member Connie Coleman-Lacadie reported that the A-I High School is participating in the Washington Business Week beginning today wherein the students will have a rigorous week-long education course for high school. She explained that the students have been broken up into small "companies" that compete with other "companies" in the assimilated world of production, marketing and finance. She added that the Lakewood Chamber of Commerce is working in partnership with the Clover Park School District, City of Lakewood, and the Foundation for Private Enterprise Education for the activity.

Ms. Coleman-Lacadie provided an update on the Youth Council's food drive wherein the middle and high school principals were asked to participate and encourage their students to help with this effort.

Ms. Coleman-Lacadie announced that Clover Park School District will be hosting a seminar wherein Ms. Sally Brownsfield will present "Motivating Native American Students: Strategies that Work" on March 31, 2003, at 3:30 p.m., to help Native Americans to be successful.

Ms. Coleman-Lacadie spoke about the success of the last *Community CafÃ* @ session with more and more students, parents and teachers participating.

Keep Lakewood Beautiful Advisory Board Annual Report.

Michael McGovern, Chair, Keep Lakewood Beautiful Advisory Board, presented an annual report and a Powerpoint slide show of the beautification projects completed by Keep Lakewood Beautiful.

PUBLIC COMMENTS

Speaking before the Council were:

Dennis Haugen, 6528 Mt. Tacoma Drive SW, spoke about insurance rates. He commented on the lack of maintenance of overgrowth vegetation causing traffic visibility hazards. He then spoke about initiative petitions.

Glen Spieth, 5928 Steilacoom Boulevard, announced that the Lakewood Historical Society will be holding a meeting at the Flett House. He also announced that a tour of Linda Evans' home will be held in June and that the tour size will be limited. He then reported on a broken vehicle window from users of the skatepark.

Larry Else, 9702 Veterans Drive, on behalf of the American Lake Improvement Club, is offering \$2,000 to help toward the summer lifeguard program.

Ken Severe, 9644 Bridgeport Way SW, spoke about Ordinance No. 307 and expressed concern about the Ordinance.

Lt. Col. Gary Anderson, McChord Air Force Base, spoke about Ordinance No. 307 and expressed objections to the proposed code amendments to the clear zone area and encroachment in this area.

Bill Lynn, P.O. Box 1157, spoke about the Ladd family property in the clear zone and what that property could be used for which is, in effect, of no valuable use. He indicated that their request is to allow for contractor yards, manufacturing uses, and warehouse uses in which ten people per acres is allowed. He expressed concern that the proposed amendments are a taking of property rights.

Scott Wood, Lakewood, spoke about a police incident with his "no trespassing" sign and asked if the Council passed something to not cite someone if they had no money to pay.

Kathie Theoe, 7425 Ruby Drive, Pierce Military Business License, spoke about the long-term impact of putting the McChord Air Force Base in jeopardy and at risk for closure and expressed concern that the proposed amendments could do just that.
