The Pledge of Allegiance was led by Mayor Harrison.

REPORTS BY THE CITY MANAGER

City Manager Rohlfs showed a video on public safety and the police department, its Weed and Seed program, and crimefree multi-housing program.

City Manager Rohlfs announced that on November 7, 2003, the Veterans Day ceremony will be held from 12:00 p.m. - 1:00 p.m., in the Council Chambers.

City Manager Rohlfs reminded Councilmembers to provide the Mayor with their comments on the Landmarks and Heritage Advisory Board appointments.

City Manager Rohlfs announced that Lakewood Police Officer Sgt. Curtis Beaupre is recovering from an injury as a result of a police pursuit.

Parley Applegate, 14507 Woodbrook, announced that the Keep Lakewood Beautiful Committee will be conducting a fundraiser at the Thornewood Castle on Wednesday, November 4, 2003.

Jim Carbemean, 9013 Grammercy Place, spoke against an off-leash area in the parks.

Mike Brandsetter, 9005-81st Street SW, spoke about the last Planning Advisory Board meeting on the rezoning of 29 acres for commercial development and asked the Council to direct the Planning Advisory Board on how to address the elimination of multi-family density that was proposed for that area.

Dennis Haugen, 6528 Mt. Tacoma Drive SW, spoke about the hard work of Police Chief Saunders. He asked that the sprinkler system in rights-of-way be turned off during the cold weather to prevent hazardous conditions on roadways. He also suggested that tickets be issued to those who walk with their backs to the road.

Catherine Forte, South Tacoma Way, spoke about the Ordinance on lowering fees for off-leash laws and asked that there be enforcement of off-leash laws instead of graduated fines.

She spoke about the visit to the junior high schools, meetings with the Mayor, the Chamber of Commerce, and the Lions and Rotary Clubs. She added that Okinawa City is very much interested in economic development and is planning a trip to Lakewood in July 2004 to discuss this further.
