CALL TO ORDER

Mayor Richardson called the meeting to order at 7:01 p.m.

FLAG SALUTE

The Pledge of Allegiance was led by Mayor Richardson.

REPORTS BY THE CITY MANAGER

City Manager Neiditz reported that there were 265 calls for police service during the Fourth of July holiday, two and a half times the normal average wherein 30 citations were issued for illegal fireworks, but that no serious incidents were reported.

City Manager Neiditz reported that the sewer agreement for Tillicum/Woodbrook was executed between Pierce County and the City. He added that Pierce County agreed to implement the sewer surcharge and that the Economic Development Administration grant was submitted for funding.

Councilmember Finnigan requested that a copy of the sewer agreement be provide each Councilmember and asked for information on the minimum sewer flows and if hook-ups to the sewer are required.

He then spoke about the 20 businesses north and the 20 businesses south on South Tacoma Way and expressed concern about the Redevelopment Plan at Ponders corner.

Ken Severe, Lakewood resident, provided an update on the construction of the building at Bridgeport Way SW and Filbert. He indicated that Tacoma Public Utilities moved its pole across the street and replaced it with a new Lakeview Light and Power pole in the middle of the sidewalk which creates an Americans with Disabilities Act (ADA) concern.
