#### REPORTS BY THE CITY MANAGER

## South Sound Military and Community Partnership (SSMCP) Business and Community Survey Report

City Manager Caulfield called on Program Coordinator Sierra McWilliams who reviewed the SSMCP's business and community survey results.

Discussion ensued on the 2,000 business contacts made to complete the survey and the 146 responses that were received; were there other findings in the survey that address education; and can the data be separated to compare Lakewood's response against the other cities.

## Karwan Village Mobile Home Park update

City Manager Caulfield called on Assistant City Manager for Development Services who provided an update on the Karwan Village Mobile Home Park at 2621 South 84th Street SW. He explained that the Park contains 43 units with approximately 120 individuals. Some manufactured units are pre-1975 and cannot be moved. He spoke about the number of maintenance violations in the Park. He reported that staff is working to close the Park by lack of a business license.

Discussion ensued on who staff is working with while the owner is out of the country; how many units are owned by the park owner; what types of calls do the Police receive (misdemeanors, felony calls); how many children are involved; what can the City provided for relocation assistance; how many units are leased and owned; is mandatory sewer available (sewer is available through the City of Tacoma and not Pierce County); are mobile homes exempt from sewers unless the sanitary septic system fails; can the City get some of the money back from the owners to clean it up using the abatement process; is there a one-year notice requirement to close a mobile home park (using the business license process, the City could use a lesser timeframe); is there resistance to address health and safety concerns, is State legislation needed for Council to motivate the Health Department to provide assistance; what is the underlying zoning for this property (industrial); would the owner replace a number of units with new units and clean-up the area; the Department of Commerce relocation dollars are generally not available and the waiting list is long; is the non-conforming use by property or individual pads (use goes with the park); are there electrical violations in this park; who owns the stormwater facility (City of Tacoma); is Tacoma concerned about storm drainage with septic sewers; and is there evidence of a problem with the septic sewer system when the City's walk through inspection was done.

City Manager Caulfield provided an update on the rental housing inspection program and outreach efforts. He noted that a detailed briefing will be provided the Council at its December 14 Study Session.

He reported that the City received a \$30,000 grant for domestic violence services.

He reported that the City's request for \$250,000 for sports field enhancements at Ft. Steilacoom park will be matched with \$250,000 of lodging tax funds.

He indicated that Sound Transit continues to move forward to bring forward a ballot initiative in November 2016. City staff is attending their meetings and Sound Transit is developing a process for prioritizing projects. The Executive Board will receive an update on December 4, 2015 and a plan is set to be completed by May 2016.

He complimented the Administrative Services Finance team for receiving the CAFR Annual Financial Report award. He recognized the CDBG staff for their work on the Consolidated Annual Performance Evaluation Report.

He reported on the SSMCP forum and their discussion to seek capital funding for the air corridor clear zone property.

He reported that City staff is standing by ready to react to the inclement weather forecast.

He announced that the Fallen officers food drive is underway and non-perishable food can be dropped off at the Police Station and City Hall through first week of December.

He then announced the following meetings and events.
