CALL TO ORDER

Mayor Whalen called the meeting to order at 7:00 p.m.

ROLL CALL

<u>Councilmembers Present</u>: 7 – Mayor Whalen; Deputy Mayor Mary Moss; Councilmembers Mike Brandstetter, Don Anderson (virtually), Patti Belle, Trestin Lauricella and Paul Bocchi.

ITEMS FOR DISCUSSION:

Abatement Program Update.

Housing Program Manager Jeff Gumm shared that in 2022 there were 18 dangerous building and 5 nuisance building abatement projects completed. In 2023, 9 dangerous building and 2 nuisance building abatements were completed and there are currently 15 pending projects. He then reviewed before and after photos of the properties. Discussion ensued.

Review funding allocation of \$1 Million in HOME funds and \$1.175 Million in HOME-ARP in support of Living Access Support Alliance (LASA) Gravelly Lake Commons 25-unit affordable housing development.

Housing Program Manager Jeff Gumm shared that the request to allocate funding in support of the Living Access Support Alliance (LASA) Gravelly Lake Commons 25-unit affordable housing development has been previously reviewed by the City Council on April 10, 2023 and July 10, 2023. Discussion ensued related to the project and funding. This item will come forward for City Council consideration at the August 21st regular meeting.

2024 Comprehensive Plan Periodic Review Update: Land Use.

Long Range and Strategic Planning Manager Tiffany Speir shared that individuals can visit the city's website and lakewood.wa.speaks.org to receive information about the 2023 Comprehensive Plan Periodic Review updates and to provide feedback or submit comments. She reviewed community partners who will

participate in the review process as required by state law or policy and highlighted the review and certification process for the adoption of the Comprehensive Plan.

She reviewed the land use categories and housing capacity for future development, the buildable land capacity on underutilized parcels, a map of middle housing and Accessory Dwelling Unit Areas in relation to critical area habitats, a wildfire interface and intermix map and the tree canopy goals.

She highlighted how the existing plans would be incorporated into the 2024 Comprehensive Plan noting that the Planning Commission will begin review in May 1, 2024 followed by a review by the City Council in July, 2024 with final adoption taking place by the end of 2024. Discussion ensued.

REPORTS BY THE CITY MANAGER

City Manager Caulfield shared that the investigation continues of the fire at the Jamestown Mobile Home Park, West Pierce Fire & Rescue has authorized clean-up of the debris and work continues to help relocate those who have been displaced.

He shared that a Volunteer Recognition event has been scheduled for Wednesday, September 27, 2023 starting at 5:00 p.m. at the Clover Park Technical College Rotunda and the Municipal Court has secured a grant, in the amount of \$187,000, to establish a Therapeutic Court to serve Lakewood, DuPont and Steilacoom.

He then shared that Sound Transit is updating their Sounder South Strategic Plan and applications are being accepted for the 2024 Lodging Tax grant awards.
